### From the Board Room

The Fairview Village HOA Phase I Board of Directors met Monday evening, Sept. 22, 2014 at 7:30 p.m. in the home of Pat Alfonso. At that time the board unanimously accepted the updated fee resolutions prepared by our attorneys. The purpose of the resolution is to give our HOA governing documents language to collect delinquent HOA dues. As per our attorney's recommendation, a late charge fee will be assessed in the amount of \$50 plus interest at the rate of 12% per annum. We presently have 2 properties owing 3 years dues! With new document language and attorneys who are willing to pursue these bad debts, the Board is optimistic we will get better results than what we have achieved in the past. Note: As soon as the documents are recorded at the county, they will be scanned and available on the village website.
